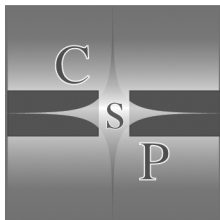

HOW TO USE THIS DIRECTORY

Information Included

The entries included in this directory are organised into three parts. All trading organisations/companies (hereafter referred to only as ‘organisations’ in this section) as of the date this book went to press, are listed in the first two sections. A third section is devoted to dormant organisations that once traded and that may continue to do so in the future.

The first part is for finding organisations by name. The second part is intended for finding organisations by location. The sorting is essentially by postcode and there is a postcodes/locations guide on p. vi which may be used as a reference for locating companies in your chosen area.

The types of information provided for each organisation are all intended to provide a first step to further research. The organisation name is that which is officially registered with Companies House, and the address is the registered address. While the registered address is not necessarily the address at which trading or indeed trading related work is carried out, letters addressed to this address are very likely to reach the employees or management of the organisation. With larger organisations, branch information is not provided unless a branch has been separately registered. The postcodes provided in this guide are not necessarily those that have been registered with Companies House or those that are included in the Companies House database. In cases where a postcode is incomplete or obviously incorrect, the postcode matching the address has been used to replace the incomplete or inaccurate postcode. However, this should not be used to assume that all postcodes in this directory are accurate or incorrect. Where a postcode is not incomplete or very obviously incorrect, no effort has been made to check its accuracy. The same applies for addresses. Companies House makes reasonable efforts to check the accuracy of information held on its database, but these checks are far from exhaustive. Apart from organisation name and address, three pieces of information have been included that may be useful for a variety of reasons. Firstly, there is the date that an

organisation was established, which may provide one of a number of possible indications of its reliability or trustworthiness. This date is essentially the date of incorporation of the organisation and does not necessarily take into account such things as prior trading under a different name or any dormant periods since the date of incorporation.

Secondly, there is the size of the organisation as indicated by its accounts type. Obtaining the exact size of an organisation is difficult if not impossible, as the idea of 'size' is highly subjective. Despite the considerable resources that have gone into the standardisation of accounting practices and the improvement of their indication of the companies assets and trading status, accounting remains a highly subjective issue and can easily be used to create a false picture of the organisation's position and size. The information provided here is simply the accounts type that an organisation submits to Companies House. Key terms included in this directory are defined below. For a more detailed explanation and indication of criteria, refer to Companies House.

Totally Exempt: The company has a turnover of under £1.4 million and the balance sheet shows less than £1 million (in the case of charities, the turnover must be below £250,000).

Small: The company has a turnover of under £5.6 million, the balance sheet shows less than £2.8 million and the average number of employees must be below 50.

Medium: The company has a turnover of under £22.8 million, the balance sheet shows less than £14.4 million and the average number of employees is below 250.

Full: The company does not qualify for any of the exemptions for very small, small, or medium sized companies.

Thirdly, an asterisk next to the postcode indicates that more than one organisation in this directory is registered to a particular address (or postcode).
